### **Booking a Try Before You Buy Loan**

Please print this form, complete it and sign it. Then photograph (using your phone, for example) or scan the first page and email or post it to the address at the foot of the page. The completed form must be accompanied by two types of identification:

- 1) a photo or scan of your photo driving licence **or** a photo or scan of the page of your current passport showing your photo; and
- 2) a photo or scan of a recent utility bill **or** similar showing your current permanent address.

You are very welcome to visit our premises by appointment to try and then take away the bassoon of your choice under this scheme, in which case there will be no charge. If you would like us to send the bassoon by courier, payment of the postage fee may be made by card on the Try Before You Buy page of our website. The postage amount payable is £30.

We will contact you to arrange delivery on a day to suit you.

#### **Delivery/Collection Arrangements**

The more expensive bassoons (high value Heckels in particular) and contrabassoons are not available for delivery, and may be tried on our premises and/or taken in person for trial. Please contact us to make an appointment to visit if you are interested in one of these instruments. These instruments must be returned in person if unwanted at the end of the loan period.

Items are sent by courier for a morning delivery on the working day agreed with you, if this service is available from the designated courier in your area.

Collection of bassoons to be returned is by courier arranged by Double Reed from the delivery address on a day agreed with you.

While we book couriers in good faith using the most reliable and professional services available, we are not in control of their actions and there may be occasions when a courier does not arrive when booked. If this happens we will strive to rearrange the booking at your convenience.

#### Insurance

Bassoons are insured\* by us while with a courier we have booked and while in your possession for the duration of the loan up to the one week limit or as otherwise agreed. The bassoon must not be loaned to anyone else and must be kept either with you (or a member of your immediate family) or in a locked and secure location at all times.

Double Reed Ltd. reserves the right to decline a Try Before You Buy loan request, and will refund any monies paid if this is the case.

\*Bassoons which need to be collected in person owing to their value must be insured by the borrower for the duration of the trial period under a specialist musical instrument insurance policy.
